Each vendor shall obtain and keep in force until completion of the fair, including clean up and tear down, a commercial general liability insurance contract with liability limits equal to or greater than \$1,000,000 each occurrence. The contractor shall provide a certificate of insurance to the Great Anderson County Fair/Drew Expositions evidencing such coverage. Such vendor shall name Great Anderson County Fair/Drew Exposition as an Additional Insured.

Contractor shall be solely responsible for any and all injuries to persons or damages of property or any other injury, claim, damage or loss of whatever nature, arising directly or indirectly from their "operation." Contractor shall INDEMNIFY, SAVE AND HOLD HARMLESS Great Anderson County Fair/Drew Exposition and its employees, agents and volunteers from and against all liability, loss, damages, claims, costs and expenses (including attorney fees) arising out of injury to person or damages to property or any other injury, claim, damage, loss, cost or expense arising from their "operation."

### APPLICATION GUIDELINES

Openings are determined after the previous year's exhibitors/concessionaires return their contracts. New Vendor applications will be reviewed in the order received and accepted based on availability.

Applications **MUST** be accompanied by a photo of your concession set up **AND** menu in its entirety. Failure to submit a photo and to fully complete the application will result in your application being rejected.

Space openings are filled using applications on file. Openings are filled with the intention of having a variety of products and services available during the Fair, not in chronological order by date.

The number of requests on file prohibits every applicant who does not receive space for any given year from being contacted.

Any application which is not legible and complete will not be considered.

**Fees are 20% of Gross sales & requires \$100.00 deposit.**
